

TERMS & CONDITIONS

IN THESE TERMS AND CONDITIONS "ROCKINGHAM" MEANS ROCKINGHAM MOTOR SPEEDWAY LTD AND "THE APPLICANT" MEANS THE COMPANY, FIRM OR PERSON APPLYING TO USE ROCKINGHAM MOTOR SPEEDWAY ("THE VENUE")

1. The applicant is responsible for the conduct of all persons in his party whilst at the venue. Rockingham reserves the right to refuse admission to any individual at their absolute discretion. Permission for admission may be withdrawn at any time at the absolute discretion of Rockingham.
2. Any vehicle used at the venue must comply with safety and noise regulations for the formula or class of vehicle as prescribed by legislation, the MSA, FIA, ACU, MCRCB or FIM in force at the time of track activity.
3. The applicant or his duly authorised representative prior to their entry upon the venue must have obtained any permissions and insurance cover as required by Rockingham covering all vehicles and persons using or entering the venue. Use of the venue will not be permitted in any circumstances if the permission and insurance cover have not been obtained and this agreement duly signed by the applicant or his authorised representative.
4. Only the portion of the venue made available by Rockingham may be used in the manner agreed and such use must be confined to the permitted hours.
5. The instructions of staff of Rockingham must be carried out. Signals to vehicles will be given by Light Signals or International Code Flag Signals and the applicant is responsible for ensuring that he and other drivers in his party understand the significance of such flags. If any driver fails to obey any of the signals or instructions Rockingham shall be entitled to suspend or ban from the activity or the venue any such driver for such period as Rockingham shall decide.
6. Rockingham may provide such marshalling and emergency services as Rockingham shall deem appropriate and save when otherwise agreed permission to use the circuit does not cover the provision of timekeepers, fire or medical services. Applicants must make their own arrangements for these services when required. In the event of medical or fire services being summoned in emergency when specific arrangements for their attendance have not been made the cost thereof shall be the responsibility of the applicant whether such service has been called by the circuit staff or some third party or the applicant or his employees or contractors.
7. The issue of the permission shall not be deemed to imply any warranty or undertaking by Rockingham by contract, common law or otherwise that the nature or physical condition of the venue and the race track and the provisions of marshals, fire or medical services and emergency services (if any) are suitable for the use contemplated by the applicant and the applicant must first satisfy himself/herself as to the safety and suitability in all respects of the venue and such services before commencing use.
8. Notification of any accident must be given to the Circuit Manager or the Health and Safety Manager or their nominated deputy at the time it occurs. If personal injury or damage to property, other than that of the applicant is caused, notice in writing giving full details must be sent within forty-eight hours to the Health & Safety Manager, Rockingham Motor Speedway Ltd, Mitchell Road, Corby, Northamptonshire, NN17 5AF, and the applicant shall not make any admission, offer, promise or payment relating to such accident.
9. If oil or any other substance likely to cause danger to others using the venue is deposited anywhere, immediate steps must be taken by the applicant to notify the Circuit Manager or the Health & Safety Manager.
10. While every endeavour will be used to keep the venue open for the whole of the period described in this application form, no claim against Rockingham shall arise in respect of the unavailability of the venue howsoever arising.
11. Where any portion of the venue is required for specific purposes other than those foreseen by governing body track licences/permits, special arrangements must be made with the Circuit Manager or his deputy to ensure general safety. Racing with any other vehicles at the venue and reckless or dangerous driving are expressly forbidden.
12. Braking, manoeuvring or other special tests shall only be carried out on the Wet Grip Facility. The following conditions apply:
 - i) Only 1 vehicle to be active on the wet grip areas at anyone time
 - ii) Maximum speed to not exceed 35mph
 - iii) Outside temperature to be a minimum 5°C
13. Use of the venue shall not commence until the Circuit Manager or his nominated deputy has given permission for the applicant to do so. Rockingham reserves the right for the Circuit Manager or his nominated deputy to suspend or cancel use by the applicant if in their opinion it is unsafe for the use by the applicant to continue, whether for the applicant's safety or the safety of others using the venue or if the applicant or any persons in his charge (Condition 1) commits a breach of the above conditions.
14. Under no circumstances will a car, or cars, be allowed to use the venue in company with a motorcycle(s).
15. Unless this condition shall be waived by Rockingham the applicant acknowledges that it is a condition of his and his driver's/rider's use of the Circuit that the applicant and/or each driver/rider shall hold a valid licence appropriate to such use as determined by Rockingham.
16. Permission to use the venue will be revoked immediately if in the opinion of the Circuit Manager or his nominated deputy the applicant has failed to observe all or any of the terms and conditions set out in this application form.
17. The applicant shall be entitled to use such pits facilities as have been agreed with Rockingham prior to the commencement of the activity. The applicant shall conduct its activities within the area designated by Rockingham so as not to cause any nuisance or disturbance to Rockingham or others who may also be entitled to use the venue and the pits area. The applicant shall not under any circumstances deposit liquid or harmful substances in the containers provided for general commercial waste.
18. The applicant shall at all times comply and ensure compliance with all regulations bye-laws or Acts of Parliament appropriate to its operation and in particular, but without limitation, the Health and Safety at Work Act and Petroleum Regulations from time to time in force.
19. Permission to use the venue is granted subject to the condition that no action or claim shall in any circumstances be maintained by the applicant, his servants or agents or any person in his party (Condition 1) against Rockingham or their servants or agents for or in respect of any act deed matter or thing done in regard to the use of the venue. The applicant accepts full and complete responsibility for any loss or damage caused or sustained by him or his servants or agents or any person in his party arising out of his use of the venue.
20. The applicant shall reimburse Rockingham the cost to Rockingham for the repair of damage to the property of Rockingham including the venue or any part of the property (which for avoidance of doubt includes the safety barriers) caused by the applicant servants or agents or any person in his party. All monies due to Rockingham under this clause shall be paid by the applicant within 14 days of the demand from Rockingham.
21. Closed circuit television is available to enable Rockingham to maintain safety cover and to manage the venue itself. Recordings from the closed circuit television system may be made at Rockingham's discretion. Such recordings if made are entirely for the sole use of Rockingham and will not be made available to any other party. If a recording has been made Rockingham may or may not retain it for its own purposes for any period of time and tapes are frequently wiped or reused.
